**THE PARTIES**

**ON THE FIRST PART:** The University of Puerto Rico in Humacao, an autonomous unit of the University of Puerto Rico, being represented by its Chancellor, Dr. Carmen J. Hernández Cruz, of legal age, married, with residence in the vicinity of Humacao, Puerto Rico from now on referred to as "**The University**".

**TERMS AND CONDITIONS**

**FIRST: The Visiting Lecturer** will offer the following conferences at the University of Puerto Rico in Humacao seminars on activities for the benefit of the university community and/or general public:

**SECOND: The Visiting Lecturer** will submit, an abstract of the topics to be covered, an outline of the seminars content and the materials to be distributed.

**THIRD:** The University agrees to pay to **The Visiting Lecturer** the amount specified below. The compensation is distributed as follows:

**FIFTH: The University** will retain, with no additional payment, the proprietary rights of any video recording or recordings made through any other technical means, of the activities related to the object of this contract as specified in the first clause of this document.

**SIXTH:** This contract does not make extensive to **The Visiting Lecturer** any rights or privileges granted to the regular employees of the University of Puerto Rico in Humacao.

**SEVENTH:** This contract is in accordance with the regulation set forth by Public Law No. 28, enacted on June 8, 1948 as amended.

**EIGHTH:** No consideration subject to this agreement can be required be either party until it has been registered in the Controller Office subject to Law 18, October 30, 1975 as amended.
